Course Description

This course explores oral communication principles common to speaking and listening. It emphasizes listening techniques as well as the preparation and delivery techniques for extemporaneous speaking.

Course Objectives/Goals

- This is an online course. All work will be done in the Canvas classroom.
- You must have reliable internet access for:
 - weekly quizzes
 - recording/uploading videos to YouTube
 - recording proctored quiz sessions
- Proctoring is not compatible with mobile phones. You must have a webcam on your computer and it must be enabled/allowed for each quiz.
- You must submit the informative and persuasive video presentations this semester to fulfill the public speaking requirement (TED Talk and Shark Tank Pitch). If you don't, you won't be able to pass, regardless of your other grades/average in class.

Textbook

None. All required readings and videos will be posted in the modules.

Technology note

Tech glitches/outages are not acceptable excuses for not submitting work on time UNLESS it is a systemwide college outage. The best way to avoid a problem is to complete all work well before the deadline.

To Communicate with your Instructor

Grading Policy

All grades will be posted within 5 days after the due date. If any points are taken off, the student will see a comment or mark in the grade book rubric to explain the deduction. *Note that not all assignments within a category carry the same weight. For example, one speech may be worth more points than another. The assignment category shows the weighting for all work in that category, combined.

Late work/Make-up policy

- All written assignments, quizzes and speeches are due Sunday at 11:59 pm.
- Discussion posts require an initial response by Friday at 11:59 p.m. and participation by Sunday at 11:59 p.m.
- The last week of work is considered the final exam work and may follow a different schedule than listed above. A schedule/deadline grid can be found in the first module in the classroom on the first day to provide info on all due dates.
- Quizzes may not be taken late.
- Everyone will have their two lowest quiz scores dropped, even if the quizzes were not taken.
- All work submitted after the assigned due date will incur a late penalty, as follows:
 - work turned in Monday - Tuesday at 11:59 p.m. will have a 30% deduction
 - work turned in Wednesday - Thursday will have a 50% deduction
 - no work is accepted after Thursday at 11:59 p.m.
- Any late penalties are taken in addition to other assignment quality-related deductions. For example, if a student turns in late work and does not meet the word count for the assignment, they will two levels of point deductions.



- All late work will be graded within one week of submission.
- Because all assignments are open at least a week, no excusals are made for doctor's visits, dentist appointments, lab work/testing, car troubles or unexpected travel.
- Please note that any notes related to extended hospitalization (overnight) will be verified. You must provide a note on letterhead and a contact phone number. No extensions will be granted until the note has been verified. Any documents found to be forged will be forwarded to the Office of Student Conduct as a violation of academic integrity standards.

Incomplete Grades

The current university policy concerning **incomplete grades** will be followed in this course. Incomplete grades are given only in situations where unexpected emergencies prevent a student from completing the course and the remaining work can be completed the next semester. Your instructor is the final authority on whether you qualify for an incomplete. Incomplete work must be finished by the end of the subsequent semester or the "I" will automatically be recorded as an "F" on your transcript.

Academic Integrity/Plagiarism

Plagiarism or cheating of any kind on an activity, assignment or speech will result in a 0 for that assignment (and may lead to an "F" for the entire course) and be subject to appropriate referral to the Office of Student Conduct for further action. If you are in doubt as to the definition of plagiarism, please see Valencia's "Rules of Conduct." "Z" grade will be given if instructor files complaint of student academic dishonesty. The student will receive earned grade with a Z preceding letter grade for the course.

Withdrawal Policy

Any student who has not participated (completed an assignment) during the first 7 days of class may be dropped from the roster. If, at any time during the semester, the student wishes to drop the course, the student is responsible for doing so, through the registrar. The instructor is not able to drop students from the course other than "no shows" in the first week. Students must be aware of all withdrawal deadlines, as these can have an impact on the student's final grade/transcript.

Incomplete Grades

Incomplete grades are given only in situations where unexpected emergencies prevent a student from completing the course, and when the remaining work can be completed the next semester. In order to qualify, the student's grade must be at a passing level at the time the Incomplete is requested. An Incomplete "stops the clock" on work moving forward. In other words, an Incomplete will not have any impact on previous assignments (for which the deadline has passed). Your instructor is the final authority on whether you qualify for an incomplete. Incomplete work must be finished by the end of the subsequent semester or the "I" will automatically be recorded as an "F" on your transcript.

Academic Progress
