4. *Grading System*

The following grading scale is used:

Grades are a reflection of achievement relative to your understanding of course objectives.

Attendance grade combined = 25% of your total grade.

Each Project = 25% of your total grade.

Project grades are determined by the discretion of the instructor according to the specific critical criteria of each project and the following:

- Group cooperation/attitude
- Effort/perseverance
- Use of value/color/composition and design as specified
- Creativity
- Challenging use of art supplies
- Craftspersonship/skill/consistency
- Time management and meeting deadlines
- Demonstration of understanding (No student will pass the course without demonstrating an understanding of course objectives). This will be facilitated through a Final Critique of the assignments and projects submitted throughout the course.)
- Following directions

- Development and improvement in successive assignments
- The fulfillment of daily classroom assignments and activities

Late work will be accepted on a case by case basis. If the reason for tardiness is due to one of the official Valencia excused reasons for absence, documentation should be provided to corroborate it as such. No work will be accepted after the final Project deadline.

Course may change according to particularities of this class or because of this group of students' needs. If some aspect of this syllabus needs to be amended, I reserve the right to make changes as necessary.

5. *Attendance*

Every unexcused absence over 2 will result in a 5% drop in the overall grade. Participation and productive effort is considered a requirement of "Attendance".

Tardies: Tardy calculation is cumulative. A missed hour is considered an Absence. Leaving early is also considered tardy.

6. *Withdrawal Policy*

- Withdrawal: Students will be responsible for withdrawing themselves from the course, if necessary.
- Incomplete: An "Incomplete" grade will be issued by the instructor only in extreme or extenuating cases.

Per Valencia Policy 4-07 (Academic Progress, Course Attendance and Grades, and Withdrawals), a student who withdraws from class before the established deadline for a particular term will receive a grade of "W".

A student may withdraw at any time during the term in Atlas. The New Withdrawal Policy has been implemented. Here's what you need to know about the new Withdrawal Policy:

- Students may withdraw themselves for a W up until the withdrawal deadline.
- After the withdrawal deadline each semester, students can no longer withdraw themselves.
- WP and WF have been deleted from Withdrawal procedures.

- Before the withdrawal deadline, both a student and faculty may withdraw the student.
- After the withdrawal deadline, a student cannot withdraw him-/herself.

Excessive absences/ Lateness of fifteen minutes or early departure will count as a miss hour. A professor can withdraw you from a course for excessive absences without your permission. (2002-03 College Catalog p.62) Do not leave early without informing me. This is disruptive and rude.
