COURSE DESCRIPTION: Introduction to law, its social forces and agencies for enforcement; effects of governmental regulation on business and society, including environmental law, community planning and consumer protection; contracts; and personal property, including bailments and sales.

Many of the legal concepts stated above will interact in practice (e.g. where you bring a lawsuit against a business may depend upon the type recovery allowed by a state or federal statute). Therefore, you may see multiple concepts explored in a single discussion or case study.

Assessment

Assessment: This course will measure learning to ensure major learning outcomes are achieved. All of the assessments will be posted on Canvas and will have to be submitted on there.

- Multiple-choice demonstrates your ability to recall legal concepts drawn from
 discussions, your notes; reading the text; and supplementary course materials
 (e.g. shared articles, videos etc.). This assessment method also demonstrates
 your ability to think critically when selecting the best answer to a given
 question.
- Case Briefs allow students the opportunity to perform legal analysis by performing law/fact analysis. Students will use the IRAC method of legal analysis (Issue, Rule, Application, and Conclusion).
- Peer-to-Peer communication is vitally important in any business career. In
 most lawsuits, and you will inevitably see miscommunication is somehow
 related. In this course, weekly discussion board assignments will demonstrate
 your ability to communicate effectively in writing; and provide valuable
 feedback to your peers. Emphasis—when formulating discussion board
 grades—is placed on critical thinking, courtesy, punctuality and
 professionalism.

Grading

Submitted content is assessed on a cumulative 1,000 points. Because punctuality is an essential trait of effective managers—and graded assignments are discussed in-depth (both in gradebooks and discussion threads) once assessment is complete—late submissions are generally not accepted. Contact Professor Richards if you anticipate being unable to complete work by a due date.

Three (3) multiple choice quizzes*. Each exam will consist of 20 questions. Students may use their textbooks, notes and supplementary materials.

Case Briefs – Two case studies will be analyzed during the course using the IRAC formula, favored by law schools. The goal of a case brief is helping students see a conflict as a lawyer sees it, and conducting basic law/fact analysis.

Analysis and Peer-to-Peer Communication – There will be 9 discussions created, which allows you to analyze business law topics; and provide feedback to your classmates. This learning method is designed to sharpen writing and critical thinking skills; demonstrate an ability to research legal issues; and communicate effectively in a virtual setting.

Attendance, Withdrawal & Policies

Attendance Policy – With the Covid-19 situational factors at play, students should stay home if feeling ill. The general policy is that students are allowed three (3) unexcused absences. Of course, if there are extenuating circumstances exceptions can be made. Withdrawal will be made on a case-by-case basis.

^{*} This course does not have a "Final Exam". That is, the 3rd quiz is not cumulative for the entire semester. Students who miss the 3rd quiz will earn a zero grade, which be calculated into the weighted average. Professor Richards places a priority upon submitting final grades early.

Make-Up Policy – Students are adult learners responsible for both their actions and inactions. As such, tardiness with regard to completing assignments is considered unprofessional and is generally not condoned. Weekly discussion board posts are generally not accepted late for academic credit since feedback is given to the class, which would give the student who submits late an unfair advantage. Case study and/or multiple choice exams/quizzes may be submitted late given extenuating circumstances. Quiz #3 is not accepted late, as grades are submitted to the registrar promptly upon completion of the course.
