WITHDRAWAL POLICY

Per Valencia Policy 4-07 (Academic Progress, Course Attendance and Grades, and Withdrawals), a student who withdraws from class before the established deadline for a particular term will receive a grade of "W." STUDY TIPS

LEARNING IS AN ACTION VERB!! Most students need to do more than just sit through lectures and reread their notes. Spend 1-2 hour blocks of time EVERY DAY actively writing or discussing concepts to make them a part of your memory. Use the words you learn often. The meaning will sink in better.

Here are some study and classroom management tips that have assisted former students:

- <u>Attend class daily and don't be tardy</u>. The introduction to each lecture explains the purpose of the entire lecture. Students who follow this rule won't miss important information.
- Read the textbook material prior to the scheduled class.
- Actively participate in classroom lectures and discussions over the chapter material.
- <u>REWRITE YOUR NOTES</u> soon after the lecture; if the instructor permits, <u>tape record</u> lectures and replay to refresh your memory when you rewrite your notes.
- Create flash cards with questions you make up from the lecture and lab with answers on the back.
- Use mnemonic devises and other games to remember concepts; go to Google images,
 YouTube and Khan Academy for additional pictures and videos to clarify concepts.
- Make lists of confusing topics from your studying and ask questions.
- Take advantage of the professor's office hours.
- JOIN A STUDY GROUP and predict what questions the professor could ask on the test.
- Get the telephone number of one or more buddies in case you are absent from a class.

GRADING CONSIDERATIONS

- One letter-grade reduction towards final grade for more than two absences
- All late assignments will result in an automatic grade reduction of 10%.
- No assignment or test will be accepted after one week past the due date.
- Assignments may be placed in the instructor's mailbox in building 2-208 and stamped indicating date submitted for credit.
- Quizzes will **NOT** be made up beyond the due date.
- There will be NO CURVE for any test (lecture or practical). The only extra points applied will be based solely on statistical data from the class score report where the overall AND the top 27% of the class scored less than 60% on any single question.

The only extra point opportunities are solely based on your cumulative final examination whereby the final exam score may replace your lowest written examination grade.
