## **Course Description**

This class is designed to help students understand five key features of the United States Government: 1. The role of government in the America; 2. The American System including the American people, the Constitution, and Federalism; 3. Links between people and government through public opinion, news media, interests groups, political parties, elections, and money and politics; 4. The Institutions: Congress, the Presidency; The Bureaucracy, and the Judiciary; and 5. Civil Liberties and Rights encompassing both civil liberties and civil rights.

## **Course Objectives**

Upon the successful completion of this course students will be able to demonstrate the following skills and abilities:

- ✓ Create an advanced understanding and appreciation of the history, study, and practice of the US government.
- ✓ Identify, discuss, and compare the various components of the US Government.
- Review and critique the strengths and weakness of each component in relation to their applications to government.
- ✓ Discuss each point delineated in course description
- ✓ Understand national, (federal), state, and local governments.
- ✓ Develop the necessary government skills to deal with real world situations.

#### **Course Format**

The course is divided into lecture sections and each section comprises of three components: an introduction overviewing the topic being examined; Power-Point slides summarizing the major points of

the readings; and assignments which include weekly research tasks associated with the theme(s) being discussed. In-class activities include lectures, and discussions of assignments.
