#### **INTRODUCTION**

This syllabus is a contract between the student and the instructor. By enrolling and participating in this course, the student agrees to and accepts the terms and conditions of this contract. # **COURSE DESCRIPTION**

This is a fully ONLINE course with many online components, conducted in a full-term period. You must work quickly, and there is no specific time when you must be logged-on to the course.

The course is an introduction to basic macro and micro economic theory and fundamentals of economic analysis. Emphasis is on the study of economic fundamentals: market structure, price determination, factors of production, distribution of income and effects of competition, monopoly and oligopoly on markets; GDP, unemployment, inflation, fiscal and monetary policy. The student will also be introduced to international trade and the world economy.

# **GENERAL COURSE OBJECTIVES:**

- Understand how scarcity frames the basic economic decision-making process and resource allocation.
- Recognize the role that self-interest and rational behavior play in the decision-making process.
- Use the role of theory and economic models to analyze individual, business and government decisions.
- Understand the market system and how prices are established.
- Describe the concept of profit and the components that impact profit in a market economy.
- Comprehend the various market structures on prices, output and profit.
- Understand the historical rationale for and impact of government involvement in the micro economy (cultural and historical understanding).
- Understand the role government plays in establishing fiscal and monetary policy.
- Understand the process of measuring gross domestic product, unemployment and inflation.
- Understand the basis for and implications of international trade.

# HOW THIS COURSE DIFFERS FROM A FACE TO FACE COURSE WITH ONLINE COMPONENTS.

- 1. It can feel overwhelming. If you have not taken an online course previously, it may take a while to learn your way around the virtual campus. you must get moving fast! Avoid the eleventh hour rush and trying to cut corners. Regardless, the instructor will always be available and will guide you throughout the process.
- 2. It fits more easily into your schedule. However, since you will do about fifty percent of your work outside of a classroom, it requires more self-discipline in setting aside time to study and participate in the course's learning activities.
- 3. As in any course in which you want to do well, this course will take more time than you expect.
- 4. All reminders of when things are due are electronic. If you don't access the course regularly, you may miss key assignments and due dates.
- 5. You will collect, reflect on, and respond to information you have gathered. In an online course, responsibility for learning rests equally on students and faculty.
- 6. It works best when you enjoy using technology and interacting with others online an.d in person.

# WHAT YOU WILL NEED TO BE SUCCESSFUL

- 1. Access to a computer with a high-speed connection.
- 2. Basic computer skills, such as the use of word processing software, sending email with attachments, uploading and downloading files from external sources.
- 3. A preference for visual or kinesthetic learning because online learning is very visual and very "hands-on-the-keyboard."
- 4. An open-minded attitude, personal honesty, and a willingness to share your knowledge and ideas with others.
- 5. The belief that online and in-person learning is more convenient, but not easier than 100% face-to-face learning.
- 6. The belief that quality learning can happen anytime and anywhere.
- 7. An interest in self-reflection.

# **ONLINE COMPONENTS FOR THIS COURSE**

<u>Note:</u> Complete all learning activities on time as a sign of your respect for your peers and for the online learning environment. This means paying careful attention to deadlines and meeting them. Deadlines are posted on the course calendar and, where appropriate, the weekly modules. Please note that because deadlines are spaced throughout the weeks, it will NOT be possible to complete this course successfully by working on it only on weekends or on the last few weeks the course is open.

# WHAT YOU CAN EXPECT FROM ME

- 1. Prompt responses to your questions and emails, usually within 24 hours.
- 2. Frequent monitoring of course website.
- 3. Thoughtful discussion facilitation (although I may limit my involvement so you spend more time in discussion with peers).
- 4. Prompt action on technical problems within my control, such as broken links, missing files, discussion settings, etc.

5. Respect for you as an individual, as well as for your ideas and opinions.

# HOW YOU WILL BE EVALUATED AND GRADED

You will be evaluated and graded on the basis of your performance on the following:

<u>Tests</u>. There will be three tests during the term. These tests will be taken through CONNECT and will be comprised mostly of multiple choice and true/false questions. They will be timed and will be required to be taken by specific deadlines. Students will have only one (1) opportunity to take each test, and once they start them, the tests will close by the end of the allowed time, whether they have been completed or not. A student who fails to take test one or two by the deadline because of a valid, written emergency (as defined by the instructor) will be allowed to take it/them at a later date without any penalty. Otherwise, if no written proof of valid emergency is provided, the student will be penalized 10% of the test grade. <u>There is no provision for taking the final exam (test 3) past the specified deadline.</u>

<u>Course Project.</u> There will be one individual course project. The project may be, at the option of the student, 1) a term paper on a topic selected by the student from the list provided in the link "Topics for Discussions or Research Paper (see below) OR, 2) a hypothetical financial plan (open the links "Hypothetical Financial Plan Basic Guidelines" and "Hypothetical Financial Plan Basic Format" provided below for specific instructions and details on requirements, sample format, etc.) If you elect to do a term paper, it must be at least five FULL pages long (not including cover page and works cited page), double-spaced, in font no larger than 12pt, and must include the pros and cons and your personal conclusion on the topic discussed. Paper format may be MLA or APA. Works cited page is required, and it is worth 10% of the paper grade. The term paper OR financial plan must be submitted through Canvas (in Excel, Word or PDF format, attached to an email to me) no later than the due date specified in the *Assignments* link. Late term papers or hypothetical financial plans will be penalized 10% for each day late (including weekend days), and none will be accepted after the final exam date.

<u>Quizzes.</u> There will be 10 (ten) quizzes during the course, with the six with the highest score each accounting for 3% of the total course grade (the 4 with the lowest scores will be dropped for grading purposes). Quizzes will be taken through CONNECT and will be in the form of multiple-choice and/or short-answer questions and problems. They will be timed and will be required to be taken by specific deadlines. Students will have only one (1) opportunity to take each quiz, and once they start them, the quizzes will close by the end of the allowed time, whether they have been completed or not. There will be no make-up quizzes.

<u>Discussions.</u> There will be four class discussions in Canvas. Each discussion will count for 3% of the total course grade. Discussion 1, which is found in the Orientation Module and also in

Module 1 Week 1, will be used to introduce yourself to the class. Topics to be discussed in discussions 2, 3 and 4 will be selected at the beginning of the course. Due dates to complete **all 4** discussions are included in the *Assignments* link. For more detailed instructions on the discussions and the deadlines, go to the link *Discussions* in Canvas. <u>There will not be any make-up discussions</u>.

<u>Smart Book (SB) assignments.</u> There will be fifteen SB assignments in the Connect platform during the course, each worth 10 points (1% of the course grade). Note that all Smart Book assignments include a deadline, and any student who does not complete the assignment by the deadline will receive a grade of zero on it. CONNECT will allow students to take the SB assignments more than once, and the attempt with the highest score will be retained for grading purposes. <u>There will not be any make-up SB assignments</u>.

#### **SEQUENCE OF ONLINE COURSE ACTIVITIES**

This is a full-term course. Therefore, it is best to progress toward the end of this course on a sequential, week-to-week basis. Weekly activities, including quizzes, tests, readings, videos, and SB assignments MUST be completed before proceeding to the following week. Weekly activities as well as deadline dates are posted on the Course Summary below this syllabus as well as the weekly modules. Remember, you must meet all deadlines to receive credit for this course.

#### TIPS FOR SUCCESS

- 1. Print a copy of the *syllabus*, and the *Assignments* link. Keep them by your computer so you can easily check what is due and when.
- 2. Work offline if you prefer. Print your assignments and read them offline; use a word processor to compose your work before posting it to the course.
- 3. Check the course website and course email frequently and regularly.
- 4. If you have a question, post it on the *Help Forum*, under the *Discussions* link. Often, a peer or your instructor will have a good answer for you. Or, if you prefer, call me (my

cellphone number is 407-579-8035). If you call, I may not pick up the phone, so be sure to leave your name and the phone number to call you back.

- 5. Set aside specific times to complete learning activities. If not, your other work will expand to fill all the time you have. If you do not make your professional development a high priority, you will not be successful at it.
- 6. Before taking any exam, make use of the study guides for tests to better prepare for "the real thing."
- 7. Quizzes are included in the CONNECT platform; study guides for tests are included in Canvas, though the actual tests will be taken in CONNECT.
- 8. Expect electronic glitches/power outages and plan ahead. Don't wait until the last minute to submit your work. Assignments with a due date shut down once the deadline is past, and they will NOT be re-opened.
- 9. If the course website has been working well for you, but begins to "act up," contact the Help Desk immediately (407-582-5600). Don't put it off!!

# **COURSE POLICIES**

- 1. Valencia's attendance policy is that a student will be present (in the classroom and online) for all course activities, as necessary. Failure to be in the classroom/sign on (on online days) and/or failure to participate in weekly online activities will count as an absence for the week no participation takes place. After two weekly absences, a student may receive an excessive absence notice and must contact the instructor immediately. A student may be withdrawn after four absences (excused or unexcused). Make-ups for scheduled tests must be requested before the test date and are subject to approval of the instructor.
- 2. Students must do their own work; there are no exceptions. Students who plagiarize or cheat risk dismissal from the course and expulsion from the college. Each student is required to follow Valencia policy regarding academic honesty. All work submitted by students is expected to be the result of the student's individual thoughts, research and self-expression, unless the assignment specifically states "group project" or similar language. The minimum penalty for cheating is a grade of zero on the particular work.
- 3. Students must have an active Atlas account. Students must check their Atlas e-mails regularly to avoid missing any important messages from the professor. Missed messages via Atlas or any other medium may affect grades and are the responsibility of the student. Students must also access Canvas and Connect on a regular basis to complete assignments and other activities, as assigned.

A student who withdraws by the withdrawal deadline of **March 15**, will receive a grade of W. A faculty member is permitted to withdraw a student from the faculty member's class up to the beginning of the final exam period, for violation of the faculty member's attendance policy, as published in the faculty member's syllabus. A student is not permitted to withdraw from this class after the withdrawal deadline. If you remain in the class after the withdrawal deadline, you can only receive a grade of "A", "B", "C", "D", "F" or "I" based upon your academic achievement upon the completion of all course work, including the required final examination. An I grade will only be assigned under extraordinary circumstances that occur near the end of the semester. If you receive an I, the work missed MUST be made up during the following semester, at which time you will get an A, B, C, D or F, depending in your academic performance for the entire course. Failure to make up the missed work during the following semester will result in your getting a grade of F in the course will be assigned a grade of F. The grades of WP and WF are eliminated.

The professor will not withdraw any student for any reason before the withdrawal deadline. It is the responsibility of the student to withdraw before the withdrawal deadline, and to be aware of the date of the withdrawal deadline.
