CATALOG DESCRIPTION

Integrated examination of dominant ideas in Western culture expressed in art, literature, music, philosophy and religion. Covers period from turn of century to present. Focuses on creative forces which have shaped contemporary consciousness from pioneering work of Einstein, Picasso, Stravinsky and Wright through dominance of objective consciousness to newly emerging guiding myths of today. Gordon Rule course which requires 6,000 words of writing. Minimum grade of C required if used to satisfy Gordon Rule requirement.

COURSE OBJECTIVE

Upon completing Humanities 2250, students should be able to identify key concepts, themes, and people of the Twentieth century as well as explore the major achievements of the cultures' expression through art, science, religion, and philosophy.
