**Course Presentation:** This is predominantly a lecture, discussion, question and answer course. Learners should <u>expect to be called upon</u> and prepared to answer content and concept-related questions question. Refusing to and or being unprepared to participate will negatively affect success in the course. Some videos will be used in the class and may at times take up much of the class period. Learners will be expected to stay through the entire viewing, take notes on film content and be prepared to respond to queries. <u>Individual or paired [only two learners per group] presentations (no more than two)</u> may be later included in the calendar and will be evaluated as additional essay.

# **Course Description**

This is a 3-credit Gordon Rule writing course (will include multiple college-level writing assignments). The content of the course includes integrated examination of dominant ideas in Western culture as they are expressed in art, literature, music, and philosophy. Often referred to as "Modernity", this course covers the era of two World Wars and rampant growth in

technology. Both European and American ideas are explored in this course. To understand these cultures, learners must strive to view the philosophies, ideas, and works of art of the 20th Century the same way the authors, composers, and artists did, rather than judge them through only the lens of one's own current culture or values. The course also requires a familiarity with names, dates, places and historical details which will be demonstrated in objective/short answer exams.

### **Course Outcomes**

By the end of this class learners should have a greater understanding of the Modern Era (the 20th Century). These cultures greatly impact the present. Through the study of textual, philosophical, architectural and visual literature, students will gain the ability to recognize and comprehend some of the significant developments of the 20th century. Art, philosophy, and other literatures are to be seen as reflections of the culture and values of those who created the works. The time spent on philosophy will help to organize ideas and developments in the concrete and plastic arts in order to provide a system of guiding principles to foster a focus for critical analysis of these 20th century cultures and their influence in our contemporary times.

#### **Attendance:**

Attendance in class is very important. Lateness is rude and inconsiderate and may result in the loss of valuable information. It is also a disruption to the class and the instructor. Absence from class is the loss of information that cannot be duplicated. The first TWO absences are given without any explanation. On the THIRD absence, the Learner will be dropped from the course and receive a grade of F. In addition, every time a learner is late to class and/leaves class early will be recorded as one half (1/2) absence and will count toward the above noted absence policy. When a learner is absent from class, it is his/her own responsibility to contact a class mate, group member and acquire all information necessary to be fully prepared and to proceed when he/she returns to class. This includes having any assignments completed and prepared to be submitted or presented as the case may be.

# Withdrawal Policy:

Per Valencia Policy 4-07 "A student who withdraws from class before the withdrawal deadline of April 1, 2016 will receive a grade of "W." A faculty member is permitted to

withdraw a student from the faculty member's class up to the beginning of the final exam period, for violation of the faculty member's attendance policy, as published in the faculty member's syllabus. A student is not permitted to withdraw from this class after the withdrawal deadline; if you remain in the class after the withdrawal deadline, you can only receive a grade of A, B, C, D, F or I. An I grade will be assigned only under extraordinary circumstances that occur near the end of the semester. If you receive an I, the work missed must be made up during the following semester, at which time you will get an A, B,C,D or F, based on previous performance in the class. Failure to make up the work during the following semester will result in you getting a grade of F in the course. Any student who withdraws from this class during a third or subsequent attempt in this course will be assigned a grade of "F."

In order to academically maintain financial aid, students must meet all of the following requirements:

## Plagiarism:

The MLA Handbook for Writers of Research Papers, 5th edition states, "to use another person's ideas or expressions in your writing without acknowledging the source is to plagiarize. Plagiarism, then, constitutes intellectual theft" (30). Examples of plagiarism are: not using quotation marks to designate direct quotes, not citing paraphrased or summarized information from an outside source, and copying or buying papers and essays and presenting them as one's own. Any paper found to be flagrantly plagiarized will receive an automatic 0% grade, and the student will be given no chance for revisions. A second offense will lead to academic sanctions including, but not limited to, failure of this course ( in accordance with Policy 6Hx28:8-03). A citation error is not flagrant plagiarism, but students may not present someone else's ideas as their own. ## Writing Standards/ Rubrics (For Essay Assignments):

Students are expected to demonstrate writing skills in describing, analyzing and evaluating ideas and experiences. Written material must follow specific standards regarding citations of authors' work within the text. Students are encouraged to use the services of the college's writing center when preparing materials. Grades will be assigned for written material in accordance with the following general criteria.

NOTE: Letter grades may be assigned for any or all of the following reasons:

#### "A" Range: Outstanding achievement; significantly exceeds standards

- o Unique topic or unique treatment of topic, takes risks with content; fresh approach.
- o Sophisticated/exceptional use of examples.
- o Original and "fluid" organization; all sentences and paragraphs contribute; sophisticated transitions between paragraphs.
- o Integration of quotations and citations and/or concrete details is sophisticated and highlights the author's argument.
- o Confidence in use of Standard English; language reflects a practiced and/or refined understanding of syntax and usage.
- o Sentences vary in structure, very few, if any mechanical errors (no serious mechanical errors).

#### "B" Range: Commendable achievement; meets or exceeds standards for course.

- o Specific, original focus, content well handled.
- o Significance of content is clearly conveyed; good use of examples; sufficient support exists in key areas.
- o Has effective shape (organization), effective pacing between sentences or paragraphs.
- o Quotations, citations and/or concrete details are integrated into argument to enhance the flow of ideas.
- o Has competent transitions between all sentences and paragraphs.

- o Conveys a strong understanding of standard English; the writer is clear in his/her attempt to articulate main points, but may demonstrate moments of "flat" or unrefined language.
- o May have a few minor mechanical errors (misplaced commas, pronoun disagreement, etc.), but no serious mechanical errors (fragments, run-ons, comma splices, etc.)

#### "C" Range: Acceptable achievement; meets standards for course

- o Retains overall focus, generally solid command of subject matter
- o Subject matter well explored but may show signs of underachievement
- o Significance is understood, competent use of examples, though too few concrete details
- o Structure is solid, but an occasional sentence or paragraph may lack focus
- o Quotations, citations and/or concrete details are integrated into argument
- o Transitions between paragraphs occur but may lack originality
- o Competent use of language; sentences are solid but may lack development, refinement, style
- o Occasional minor mechanical errors may occur, but do not impede clear understanding of material
- o No serious mechanical errors (fragments, run-ons, comma-splices, etc.)

#### "D" Range: Unsatisfactory achievement; does not meet acceptable standards

Note: The "D" grade is a passing grade; but a D will not satisfy the Passing Grade Requirement of the Course (which is a C or better).

- o Significance of content is unclear
- o Ideas lack support, elaboration
- o Lacks sufficient examples or relevance of examples may be unclear
- o Support materials is not clearly incorporated into argument
- o Expression is frequently awkward (problematic sentence structure)
- o Mechanical errors may often impede clear understanding of material
- o May have recurring serious mechanical errors (fragments, run-ons, comma splices, etc.)

#### "F" Range: Fails to meet minimal standards

- o Ignores assignment
- o Lacks significance
- o Lacks coherence
- o Includes plagiarized material (intentional or unintentional)

- o Lacks focus
- o Difficult to follow due to awkward sentence or paragraph development
- Mechanical errors impede understanding

**B** Commendable Achievement: Exceeds standards

**C** Acceptable Achievement: Meets standards

**D** Unsatisfactory Achievement: Below standards

**F** Failing

## **Cell Phone or Texting in Class:**
