III. EDUCATIONAL MATERIALS:

IV. COURSE DESCRIPTION:

Presentation of the physical and chemical properties, dosages, methods of administration and therapeutic usage of pharmaceutical preparations used in dentistry.

V. COURSE OBJECTIVES: Major Learning Objectives

The student will demonstrate:

- A. Knowledge of the general principles of pharmacology including actions, effects, administration and untoward effects of drugs.
- B. The ability to identify the basic drug groups.
- C. The ability to identify classifications of drugs and to utilize the <u>PDR</u> and <u>Drug</u> <u>Information Handbook for Dentistry</u> to appropriately fill-out prescriptions for medications commonly used in dental care.
- D. The ability to identify appropriate methods of pain control. (Pain control specific to dental care will be covered in a separate dental hygiene course.)
