Course Description:

This course is a study of the functions of human resource management including recruitment, selection, benefits and compensation, performance evaluation, development of employees and formulation of human resource procedures. The strategic role of human resources and current issues will be discussed.

Course Major Learning Outcomes:

Students will be able to:

- Define and apply foundations of human resources management.
- Identify and understand recruitment and selection issues.
- Define and understand the performance appraisal.
- Identify various approaches to training and development.
- Analyze and understand compensation and benefits issues.
- Develop an understanding of the collective bargaining and labor relations process.
- Analyze and apply employee safety and health issues.
- Apply management theories to organizational issues and situations.

COURSE POLICIES

Assignments:

Discussion Instructions (Initial Post is Required before “Viewing” Peer Posts): **You are required to submit a substantial response.** A substantial response is one that stays on topic and fully addresses the assignment in a clear, concise, and meaningful manner. Substantial Content refers to providing relevant content toward the actual topic of the discussions. This includes quality input, questions and information in your discussion posts and responses to peers.

The deliverable length of an initial thread must be at least 150 words. After the initial posting, students are required to respond to at least two (2) peers’ responses. Peer responses must be at least 50 words for each response, in order to receive full credit. Discussions must be the student’s original thoughts based on the topics from the "**Open Educational Resource**" (OER) Course Textbook and/or other referenced sources. Direct quotes from references must be less than 10 words. Plagiarized discussions will result in a "0" for the submission of this assignment. Please review postings for sentence structure, grammar, and punctuation errors. Since the discussions are more valuable to your learning experience when as many students in the class participate as possible and you are required to post two peer reviews. **Late submissions on DISCUSSIONS assignments are not accepted. Module #1 DISCUSSION “Getting to Know Each Other” is required to determine any “No Show” students.** I will drop the lowest grade in DISCUSSIONS at the end of the semester when I calculate your final grade in the course.

Discussion Posting Rules

- Personal attacks of other students because of their posts will not be tolerated.
- Provide clear analysis and insight into the topic or questions.
- Post original thoughts to avoid plagiarism and the penalties for plagiarism.
- Zero or minimal credit will be given to students with very FEW or NO SUBSTANTIVE postings.
- Proof postings to eliminate offensive references, poor sentence syntax, misspelled words, etc.

Exercise Instructions: **You are required to submit a 4-Page (Title Page, 2-Content Page, Reference Page), APA formatted paper with substantial content.** Substantial content requires staying on topic and fully addresses the assignment in a clear, concise, and meaningful manner. The deliverable length of your posting responses must be at least 4-pages, (Title Page and Content Page) APA format. Please review your paper for grammar and punctuation errors.

Exercises must be the student’s original thoughts based on the topics from the "**Open Educational Resource**" (OER) Course Textbook and/or other referenced sources. Direct quotes from references must be less than 20 words. Plagiarized exercises may result in a "0" for the submission of this assignment. Please review postings for sentence structure, grammar, and punctuation errors. **Late submissions will be deducted 2 points for each day it is late. You will have one week past the due date to complete any EXERCISE before you receive a “0” grade. Additionally, all EXERCISE assignments are required to meet the course requirements.**

Exam Instructions: **Mid-Term/Final Exam contains “critical thinking” randomly selected essay questions.** Students will be instructed in and will apply critical thinking skills to include creative thinking, innovation, inquiry, analysis, evaluation, and synthesis of information. Students will be instructed in and will apply knowledge, skills and ability to include development, interpretation, and expression of ideas through written communication.

Students will have 2 attempts to complete the exam with no time limit to complete the exam. Students must complete the entire exam in the attempt (If the exam or the web browser is closed - the exam is considered completed). This is the reason I give you 2 attempts. The exam consists of 5 randomly selected essay questions based on the related chapter(s) learning objectives of each module covered thus far. Each attempt of the exam may have different questions as they are randomly selected.

Students are required to read and fully answer the essay questions in order to receive full points. Students are required to submit a substantial response to each essay question. A substantial response is one that stays on topic and fully addresses the essay question in a clear, concise, and meaningful manner. Some essay questions required the student to provide examples to support the essay question being answered. The deliverable length of answer must be at least 150 words. Please review your answers for grammar and punctuation errors.

Quiz Instructions: You will take 4 short, multiple-choice quizzes in this course from the chapters covered in the textbook. Students will need to access the Canvas classroom page to take the exam and will receive their grades immediately upon completion of each quiz. Each quiz will contain 10 multiple choice questions worth 4 points for a total of 40 pts per quiz. All quizzes will count towards your final grade.

Make-up Exams:

Make-up exams will only be given in emergency situations provided the instructor is notified in advance (prior to the absence). Upon approval of your absence, the exam will be placed in the testing center. Exams must be made up before the next class meeting. Any test missed will have an adverse effect on your grade, and make-up test will not be given unless approved by the professor prior to the date of the scheduled test. Proof of absence is required for make-up exams.

Expected Student Conduct:

For Online Attendance

Each module contains an assignment for DISCUSSION and EXERCISE with the exception of the Midterm and Final Exam. Students are required to complete at least one assignment per week to receive credit for attendance for the course. Additionally, all EXERCISE assignments are required to meet the course requirements. If a student is absent two or more weeks of the semester, the Professor has the ability to enter a grade of 'W' and withdraw the student from the course. Attendance records are provided to the Registrar at the end of the semester along with Final Grades. Although attendance is not calculated in your final grade, attendance is required by the Registrar as outlined in the following section.
